

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.theoceansrevolt.com](http://www.theoceansrevolt.com), and The Oceans Revolt and governs data collection and usage. The The Oceans Revolt website is a ecommerce: Books and related products site. By using the The Oceans Revolt website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, The Oceans Revolt may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer

If you purchase The Oceans Revolt's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

The Oceans Revolt collects and uses your personal information to operate and deliver the services you have requested.

The Oceans Revolt may also use your personally identifiable information to inform you of other products or services available from The Oceans Revolt and its affiliates.

### **Sharing Information with Third Parties**

The Oceans Revolt does not sell, rent or lease its customer lists to third parties.

The Oceans Revolt may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to The Oceans Revolt, and they are required to maintain the confidentiality of your information.

### **Tracking User Behavior**

### **Automatically Collected Information**

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
